

## END USER LICENSE AGREEMENT

Unless otherwise agreed in a separate agreement signed by G2 Integrated Solutions, LLC (“G2-IS”) and the person or organization agreeing to these terms (“Licensee”) that specifically references and supersedes this End User License Agreement (“EULA”), this EULA governs the download, installation, and use of G2-IS’ software and any accompanying documentation (together, the “Software”) by Licensee. By clicking “I Agree”, or by downloading, installing or otherwise using the Software, Licensee agrees to the terms of this EULA. If an individual is entering into this EULA on behalf of an organization, such organization is hereby deemed Licensee and such individual represents and warrants that such individual has the power and authority required to bind such organization to this EULA; such individual will be the sole, named individual able to exercise the rights granted herein on behalf of the Licensee.

### 1. LICENSE GRANT.

**1.1** Conditioned on the timely payment of the applicable fees and upon Licensee’s continuing compliance with the terms and conditions herein, G2-IS grants to Licensee for the License Term (as defined below) a non-exclusive, limited, personal, revocable (in accordance with this EULA), and non-transferable license to download, install and run a machine readable copy of the Software, solely for Licensee’s internal business use and solely in accordance with any manuals, instructions and documentation provided by G2-is as may be updated from time to time by G2-IS (“Documentation”) and to make a reasonable number of copies of the Software for backup purposes as part of Licensee’s normal computer data-backup routine or to install the Software on non-production computer systems designated for disaster recovery, failover, staging and/or testing, provided that the Software is used on a computer system that is ordinarily non-production only during temporary periods as required to carry out the designated purpose associated with the non-production computer system. G2-IS reserves all rights in the Software not expressly granted to Licensee in this EULA.

**1.2** In connection with the acceptance of this EULA, Licensee will select from one of three license arrangements: (a) a perpetual license (the “Perpetual License”); (b) a subscription license for a period of time that is selected in connection with the acceptance process (the “Subscription License”); or (c) a trial period (the “Trial License”) and pay the applicable fees for such license type as set forth in the license selection process. The duration of each such license-type is the “License Term”.

**1.3** G2-IS may deliver to Licensee or include in or with the Software a token or other device that verifies that the Software is properly licensed, and that Licensee is in compliance with this EULA (each, a “Token”). Licensee will use the Software at all times in accordance with the Documentation, including, if required, by maintaining an internet connection that enables G2-IS to verify the validity of the Token. **The Software may stop functioning after the License Term or if the Software is unable to verify the validity of the Token.** Licensee’s continued use of the Software under the Subscription License model is contingent upon Licensee maintaining a current subscription, including timely paying all fees due. G2-IS may invalidate a Token and disable the use of the Software immediately if any payment is not made when due.

**1.4 LICENSE RESTRICTIONS.** Except as expressly permitted by this EULA, to the maximum extent the following restrictions are permitted by applicable law, Licensee will not (and will not permit, assist, or encourage others to): (a) copy or modify the Software, including, but not limited to, adding new features or otherwise making adaptations that alter the functioning of the Software; (b) separate components of the Software for independent use or for use with other software, computer code, data or information, or merge the Software into another product; (c) make, alter, adapt, translate, make derivative works of, reproduce, publish, publicly display, republish, upload, post, repost, transmit, mirror, distribute or redistribute the Software in any way without G2-IS’ specific written consent; (d) remove or modify any legends, product identification marking or any patent, copyright, trademark, or other proprietary or legal notice or marking on or in the Software or copies thereof; (e) grant any security interest in or lien on the Software, or otherwise impose or permit any other encumbrance with respect to the Software; (f) transfer, sublicense, rent, lease, sublicense, lend, sell, assign, market, or distribute the Software to any third party; (g) make the functionality of the Software available to any person other than the sole named user through any means, including, but not limited to, by uploading the Software to a network or file-sharing service, or through any hosting, application services provider, service bureau, time-share, software-as-a-service or any other type of services; (h) reverse engineer, disassemble, decompile, or discover all or any portion of the source code or underlying ideas, methods, processes or algorithms of the Software or any data or information contained in the Software; (i) disclose the results of any Software performance benchmarks or test results to any third party without G2-IS’ prior written consent; (j) use any trademarks, logos, service marks, trade names of G2-IS’ or any portion thereof, without G2-IS’ prior written consent; (k) use the Software, or any portion thereof, in a manner that does not comply with applicable law, regulations, or governmental orders; (l) use or store the Software on equipment not owned or controlled by Licensee. Licensee will be liable to G2-IS for any act or omission of any employee, contractor or other user of Licensee’s copy of the Software (or any copy thereof) to the same extent that it would have been had it committed such act or omission. Licensee will promptly notify G2-IS of any actual or suspected unauthorized use of the Software.

**2. G2-IS OBLIGATIONS.** G2-IS will use commercially reasonable efforts to provide to Licensee the support services (as set forth at [knowledgecenter.g2-is.com/buy/](http://knowledgecenter.g2-is.com/buy/) the “Support Services”) for the most-current released version of the Software: (i) for Subscription Licenses and Trial Licenses, during the applicable License Term, and (ii) for Perpetual Licenses, only during the Warranty Period (as defined below), in each case, unless otherwise provided in a separate, valid, written agreement between G2-IS and Licensee. No Support Services will be provided with respect to any other license arrangement pursuant to this EULA.

### 3. OWNERSHIP.

**3.1** Licensee will own any data, reports, documents, graphs, and charts produced by Licensee as an output of the Software based on Licensee’s information pursuant to this EULA (each, an “Output”).

**3.2** Licensee’s copy of the Software is licensed, not sold. G2-IS retains ownership of the Software and all copies and

reproductions of the Software and any Documentation, and in each case, all portions thereof, including any improvements made to it, as well as all rights under copyright law, trademark law, patent law, trade secret law, and all other proprietary and intellectual property rights therein, regardless of the form or media in or on which the original and other copies may exist. The Software is protected by United States copyright law and international treaties. Licensee acknowledges that portions of the Software, including, but not limited to, the source code and the specific design and structure of individual modules or programs, constitute or contain trade secrets of G2-IS and its licensors. If Licensee provides G2-IS with any suggestions, ideas, enhancement requests, feedback, recommendations or other information relating to the Software ("Feedback"), Licensee hereby grants to G2-IS a nonexclusive, worldwide, perpetual, irrevocable, transferable, sublicensable, royalty-free, fully paid up license to use and otherwise exploit the Feedback.

**4. INJUNCTIVE RELIEF.** Notwithstanding anything to the contrary in this EULA, any breach or threatened breach by Licensee of any provision of this EULA regarding the Software or Confidential Information (defined below) would result in irreparable harm that is not fully compensable by money damages. G2-IS will be entitled to obtain specific performance, injunctive relief, and any other appropriate relief, at law or in equity, from any court of competent jurisdiction, without being required to: (a) show any actual damages or irreparable harm; (ii) prove the inadequacy of its legal remedies; or (iii) post any bond or other security (unless such bond or security is otherwise required by law, in which event, Recipient hereby agrees that a \$5,000 US bond will be sufficient).

**5. TERMINATION.**

**5.1** This EULA becomes effective upon Licensee's acceptance and will continue for the duration of the applicable License Term, unless earlier terminated in accordance with this Article 5.

**5.2** Either party hereto may terminate this EULA for cause: (i) if the other Party breaches this EULA and does not remedy such failure within 30 days after its receipt of written notice of such breach; or (ii) if the other party terminates its business activities or becomes insolvent, admits in writing its inability to pay debts as they mature, makes an assignment for the benefit of creditors, or becomes subject to direct control of a trustee, receiver or similar authority. Notwithstanding the foregoing, G2-IS may terminate the EULA and exercise all of its other rights and remedies immediately with or without notice for Licensee's failure to pay any amount when due.

**5.3** G2-IS will have no liability arising out of the termination or cancellation of this EULA. Upon expiration or termination of this EULA for any reason, Licensee will immediately uninstall and destroy all copies of the Software in Licensee possession or control. Articles 1.4, 3, 5.3, 7, 8 (pursuant to its terms), 11, 13, and 16, 17, 18 will survive the expiration or termination of this EULA.

**6. EXPRESS LIMITED 60-DAY WARRANTY.**

**6.1** Subject to Article 6.2 and 6.4, Commencing on the day this EULA becomes effective and continuing for a period of sixty days ("Warranty Period"), G2-IS warrants only that the Software will (a) conform with all material operational features and performance characteristics expressly provided in the Documentation supplied by G2-IS, if any, and (b) be free of errors and defects that materially affect the performance of these features. The foregoing warranty will not apply if you are using the Software under a Trial License.

**6.2** The following requirements must be met for the Express Limited 60-Day Warranty above to apply:

- (a) Licensee will install, implement and operate the Software in accord with the Documentation and this EULA;
- (b) During the Warranty Period Licensee will notify G2-IS in writing of any nonconformity, error or defect within 30 days of discovery (but in any event, during the Warranty Period);
- (c) Licensee must maintain (and G2-IS' must be able to confirm the existence of) a valid Token; and
- (d) Licensee will promptly and properly install Software updates, if any, received from G2-IS.

**6.3** If Licensee notifies G2-IS in writing (according to the previous Article 6.2) of any nonconformity, error, or defect in the Software during the Warranty Period, G2-IS will provide telephone consultation on such nonconformity, error or defect, and G2-IS will at its sole and exclusive option repair or replace the Software at G2-IS' sole cost and expense. **THE REMEDIES SET OUT IN THIS ARTICLE 6 ARE LICENSEE'S SOLE AND EXCLUSIVE REMEDIES AGAINST G2-IS FOR BREACH OF THE EXPRESS LIMITED 60-DAY WARRANTY.**

**6.4** Notwithstanding any other provision of this EULA to the contrary, the Express Limited 60-day Warranty will not apply to nonconformities, errors, or defects caused by:

- (a) use of the of the Software for a purpose, or in a manner, that is not consistent with the Documentation for the Software);
- (b) interactions with corrupt, incorrect, or incompatible data;
- (c) Licensee failure to utilize compatible computer and networking hardware and software in accordance with the specification provided by G2-IS;
- (d) interactions with software or firmware not provided by G2-IS;
- (e) any changes to Licensee operating-system software;
- (f) Licensee's failure to maintain (or G2-IS' inability to confirm the existence of) a valid Token.
- (g) Licensee failure to install Software updates provided by G2-IS; or
- (h) any other causes external to the Software not arising by reason of fault or negligence of G2-IS.

**6.5** G2-IS DOES NOT WARRANT OR SUPPORT ANY THIRD PARTY SOFTWARE OR SERVICES AND WILL NOT BE RESPONSIBLE FOR ANY ACT OR OMISSION BY OR ON BEHALF OF SUCH THIRD PARTY.

**6.6** ANY AND ALL WARRANTIES WILL BE VOID IF THE SOFTWARE IS DAMAGED OR RENDERED UNSERVICEABLE BY: (A) THE ACTS OR OMISSIONS BY NON-G2-IS PERSONNEL; (B) MISUSE, THEFT, VANDALISM, FIRE, WATER, OR OTHER PERIL; AND (C) ALTERATIONS OR ADDITIONS TO THE SOFTWARE NOT AUTHORIZED BY G2-IS.

**6.7** G2-IS DOES NOT GUARANTEE THAT THE SOFTWARE WILL: PROVIDE ANY SPECIFIC RESULT OR THE RESULT LICENSEE DESIRES; MEET LICENSEE'S REQUIREMENTS; OPERATE IN THE COMBINATIONS THAT LICENSEE MAY SELECT FOR USE; OPERATE UNINTERRUPTED OR ERROR-FREE; BE WITHOUT BUGS; OR WORK ON LICENSEE'S COMPUTER SYSTEM, OR THAT ALL SOFTWARE ERRORS WILL BE CORRECTED.

**6.8** USERS MUST HAVE AND EXERCISE APPROPRIATE KNOWLEDGE AND EXPERTISE TO UTILIZE THE SOFTWARE AND ANY RESULTS OR

OUTPUT FROM SAME. THE SOFTWARE IS NOT AN EXPERT SYSTEM AND RESULTS ARE NOT GUARANTEED. USERS MUST POSSESS AND APPLY SUFFICIENT KNOWLEDGE AND EXPERTISE TO OBTAIN ACCEPTABLE RESULTS. G2-IS DOES NOT HAVE ANY OBLIGATION OR LIABILITY FOR DAMAGES OF ANY TYPE RELATING TO ANY PARTY'S USE OR INABILITY TO USE THE SOFTWARE (EXCEPT AS EXPRESSLY STATED IN THIS EULA) OR INFORMATION FROM THE SOFTWARE.

**6.9 LICENSEE ACKNOWLEDGES THAT NO REPRESENTATIONS OR WARRANTIES OTHER THAN THOSE CONTAINED IN THIS EULA HAVE BEEN MADE RESPECTING THE SOFTWARE, OUTPUTS, OR SERVICES TO BE PROVIDED OR GENERATED UNDER THIS EULA, AND THAT LICENSEE HAS NOT RELIED ON ANY REPRESENTATION OR WARRANTY NOT EXPRESSLY SET OUT IN THIS EULA.**

**7. NO OTHER WARRANTY.** THE SOFTWARE, DOCUMENTATION, SERVICES (INCLUDING SUPPORT), AND INFORMATION RELATED TO THE SOFTWARE, AND ALL OUTPUTS, ARE PROVIDED "AS IS," WITHOUT WARRANTY OF ANY KIND. G2-IS DISCLAIMS, TO THE EXTENT ALLOWED BY LAW, ALL WARRANTIES AND CONDITIONS, EITHER EXPRESS OR IMPLIED, RELATING TO THE SOFTWARE, DOCUMENTATION, SERVICES, AND OTHER INFORMATION INCLUDING, BUT NOT LIMITED TO, ANY IMPLIED WARRANTIES AND CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE (EVEN IF G2-IS HAS BEEN INFORMED OF THE PURPOSE) AND NON-INFRINGEMENT, AND ANY WARRANTIES AND CONDITIONS ARISING OUT OF COURSE OF DEALING OR USAGE OF TRADE. G2-IS DOES NOT WARRANT THAT THE SOFTWARE WILL BE UNINTERRUPTED OR ERROR-FREE. NO ORAL OR WRITTEN INFORMATION OR ADVICE OBTAINED FROM G2-IS OR ELSEWHERE WILL CREATE ANY WARRANTY OR CONDITION NOT EXPRESSLY STATED IN THIS EULA. LICENSEE IS SOLELY RESPONSIBLE FOR ITS COMPLIANCE WITH LAWS APPLICABLE TO LICENSEE.

## **8. INDEMNITY.**

**8.1 Indemnification by G2-IS.** G2-IS will defend Licensee during the License Term from third party claims that the delivered Software infringes any U.S. copyright, trade secret, or patent, and will pay the resulting damages finally awarded against Licensee to such third party by a court of competent jurisdiction, or agreed to in settlement by G2-IS. This indemnity is conditioned on Licensee: (a) notifying G2-IS in writing within 10 days of Licensee becoming aware of any such claim; (b) granting G2-IS the sole right to control the defense and defend, compromise, or settle the suit or claim; and (c) providing G2-IS all available information and reasonable or necessary assistance to enable G2-IS to defend any claim. This indemnity does not apply to: (i) any modification not made by G2-IS or at G2-IS' request; (ii) content, processes, equipment, software, data, articles, information or any other materials or processes not supplied by G2-IS, or any use of the Software in combination with any of the foregoing; (iii) any continuing alleged infringement after being notified thereof or after being provided with a non-infringing substitute; or (iv) misuse of the Software or use of the

Software in a manner not in accord with this EULA or the Documentation. This Article 8.1 states the exclusive remedy and entire liability of G2-IS with respect to any claimed infringement of any person's intellectual property or other proprietary rights by the Software or Licensee's authorized use of the Software. G2-IS may also, at G2-IS' option and at G2-IS' expense: (i) obtain the right for Licensee to continue to exercise the license granted to Licensee under this EULA; (ii) modify the Software to make it non-infringing; or (iii) terminate this EULA and for Subscription Licenses refund any unused fees paid by Licensee; and for Perpetual Licenses, refund a *pro rated* portion of such fees paid by Licensee for such Perpetual License (based on a three-year useful life of the Software license).

**8.2 Indemnification by Licensee.** Licensee will release, defend, indemnify and hold G2-IS harmless from any claims, damages, liabilities, costs and fees (including reasonable attorney fees) arising from (a) Licensee's use (except to the extent G2-IS is required to indemnify Licensee pursuant to Article 8.1) or misuse of the Software, (b) Licensee's failure to comply with this EULA; (c) any claim of infringement of any intellectual property or other proprietary right by any third party to the extent the claim involves articles, information, data or software supplied, provided or modified by Licensee or any third party; (d) Licensee's use of the Outputs; and (e) the negligence or willful misconduct of Licensee.

**9. AUDIT RIGHTS.** G2-IS (or its designee) may, upon reasonable notice and G2-IS' expense, audit during business hours Licensee's compliance with this EULA. Licensee will fully cooperate with (and will provide any information, personnel or other resources requested by G2-IS in connection with) any such audit.

**10. EXPORT LAW.** Licensee will comply fully with all U.S. export laws and regulations to ensure that neither the Software nor any technical data related thereto nor any direct product thereof are exported or re-exported directly or indirectly in violation of, or used for any purposes prohibited by, such laws and regulations. Licensee is solely responsible for obtaining any and all required governmental authorizations, including without limitation, any export or import licenses and foreign exchange permits.

**11. LIMITATION OF LIABILITY.** NOTWITHSTANDING ANYTHING TO THE CONTRARY, TO THE GREATEST EXTENT PERMITTED BY APPLICABLE LAW, EVEN IF SUCH DAMAGES COULD HAVE BEEN FORESEEN OR G2-IS HAS BEEN ADVISED AS TO THE POSSIBILITY OF SUCH DAMAGES, AND WHETHER BASED IN CONTRACT, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY, INDEMNITY, OR ANY OTHER LEGAL THEORY, (a) IN NO EVENT WILL G2-IS BE LIABLE FOR DAMAGES FOR ANY SPECIAL, INCIDENTAL, INDIRECT, OR CONSEQUENTIAL DAMAGES (INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOST PROFITS, REVENUE OR GOODWILL); OR (b) G2-IS'S TOTAL AND AGGREGATE LIABILITY FOR ALL CLAIMS OF ANY NATURE ARISING UNDER OR IN CONNECTION WITH THIS EULA, THE SOFTWARE OR OTHERWISE WILL NOT EXCEED THE TOTAL FEES PAID BY LICENSEE TO G2-IS FOR THE SOFTWARE IN THE TWELVE (12) MONTHS PRECEDING THE DATE ON WHICH THE FIRST CLAIM ARISES UNDER THIS AGREEMENT, AND LICENSEE WILL RELEASE,

DEFEND, PROTECT, INDEMNIFY, AND HOLD HARMLESS G2-IS FROM ANY LIABILITY IN EXCESS OF THIS AMOUNT. Licensee acknowledges that the fees and limitations of liability set forth in this EULA reflect the allocation of risk negotiated and agreed to by the Parties and that G2-IS would not enter into this EULA without these limitations on its liability. These limitations will apply notwithstanding any failure of any limited remedy of its essential purpose.

**12. THIRD PARTY SOFTWARE.** The Software may include software licensed under the BSD-3-Clause open source license (relevant notices are available at <https://knowledgecenter.g2-is.com/buy>). G2-IS ASSUMES NO OBLIGATION OR LIABILITY THAT MAY ARISE WITH RESPECT TO THIRD PARTY SOFTWARE OR LICENSEE'S USE OR INABILITY TO USE THE SAME.

**13. CONFIDENTIALITY.**

**13.1 Confidentiality.** "Confidential Information" means all technical, business, financial and other information disclosed (whether in oral, written, or other tangible or intangible form) by G2-IS to Licensee concerning or related to this EULA or the Software (whether before, on or after the effective date of this EULA) that is clearly identified as Confidential Information at time of disclosure or is disclosed under circumstances that would lead a reasonable person to understand that such information is confidential. Confidential Information will not include information that: (i) is in or enters the public domain without breach of this EULA through no fault of Licensee; (ii) Licensee can reasonably demonstrate was in its possession prior to first receiving it from G2-IS; (iii) Licensee can demonstrate was developed by Licensee independently and without use of or reference to G2-IS's Confidential Information; and (iv) Licensee receives from a third party without restriction on disclosure and without breach of a nondisclosure obligation. The Software, including, but not limited to, algorithms, logic, design, look and feel, display, process and coding methodology proprietary to G2-IS, and any information related thereto, as well as the fee arrangements between Licensee and G2-IS are Confidential Information.

**13.2** Licensee will maintain in confidence the Confidential Information and will not use such Confidential Information except in connection with the exercise of their rights and performance of their obligations under this EULA. Licensee will use the same degree of care in protecting G2-IS's Confidential Information as Licensee uses to protect its own confidential information from unauthorized use or disclosure, but in no event less than reasonable care. In addition, Licensee: (i) will not reproduce Confidential Information disclosed by G2-IS, in any form, except as required to accomplish Licensee's obligations under this EULA; and (ii) will only disclose Confidential Information received from G2-IS to its directors, officers, employees and/or contractors who have a need to know such Confidential Information in order to perform their duties under this EULA and only if such directors, officers, employees or consultants have executed a non-disclosure agreement with Licensee with terms no less restrictive than the non-disclosure obligations contained in this Article 7. Licensee is liable to G2-IS to the same extent, for any use or disclosure of G2-IS's Confidential Information by its employees, contractors or agents to the same extent it would have liability had it made such use or disclosure. This does not extend or broaden the scope of the license granted to Licensee in the Software, as set forth in Articles 1, **Error! Reference source not found.**, and

1.4, and this Article 13 is subject to the terms thereof with respect to the Software.

**13.3** Any disclosure made pursuant to a judicial, legislative or administrative order or proceeding will not be in breach of the obligations of this Article 13 if, to the extent permitted by law, Licensee provides G2-IS with prior notice of the intended disclosure and cooperates with G2-IS to obtain confidential treatment for such disclosure.

**14. ASSIGNMENT, SUBCONTRACTING, OUTSOURCING.**

Licensee may not assign, transfer, or delegate any rights or obligations under this EULA, whether voluntarily or by operation of law (including but not limited to any change occurring by way of sale of assets, change of control, merger, or consolidation, or other form of reorganization), without G2-IS' prior written consent. Any attempted assignment, transfer, or delegation by Licensee in contravention of this Article 14 will be null, void and without effect. G2-IS may freely transfer, assign, and delegate this EULA and its rights and duties hereunder. Subject to the foregoing, this EULA will be binding upon and will inure to the benefit of the Parties and their respective representatives, heirs, administrators, successors and permitted assigns.

**15. FORCE MAJEURE.** Neither party will be liable for damages for any delay or failure of performance arising out of causes beyond their reasonable control, including for acts of God, acts of civil or military authority, fires, riots, wars, embargoes, epidemic, or communications failures.

**16. CHOICE OF LAW AND VENUE.** This EULA will be construed according to the laws of the State of Texas, USA, without reference to conflict of laws principles, and venue for any action involving this EULA will be in the state district courts of Harris County, Texas.

**17. ENTIRE AGREEMENT.** This EULA represent the entire agreement between the parties and supersede any prior agreements, whether written or oral, and may be amended or modified only by a written amendment signed by both parties. In the event of a conflict between this EULA and a written agreement between Licensee and G2-IS, or any of their successors or assigns, not expressly stating it is an amendment to this EULA, the terms of this EULA will control.

**18. MISCELLANEOUS.**

**18.1** Unless otherwise expressly stated in this EULA, the failure of either Party to enforce at any time any term or condition herein will not be a waiver of the provision, or any other provision, or of the right of the Party to enforce any provision in this EULA. All waivers under this EULA must be in writing.

**18.2** All remedies available to G2-IS for breach of this EULA are cumulative and may be exercised concurrently or separately, and the exercise of any one remedy will not be deemed an election of that remedy to the exclusion of any other remedies.

**18.3** Any notice required or permitted under this EULA must be in writing and delivered, for G2-IS to 10850 Richmond Avenue, Suite 200, Houston, TX. 77042, and for Licensee, to the email and/or physical address you designate when you register your license, or, in each case to any other address designated by prior notice by: (a) hand delivery in person; (b) electronic mail; (c) registered or certified mail, postage prepaid; or (d) national overnight courier. All notices are deemed to have been duly given: (i) when delivered in person; (ii) when

transmitted by electronic mail, if followed by transmittal by national overnight courier for delivery on the next business day; (iii) upon receipt after dispatch by registered or certified mail, postage prepaid; or (iv) on the next business day if transmitted by national overnight courier (with confirmation of delivery).

**18.4** There is no joint venture, partnership, agency or fiduciary relationship existing between the parties hereto and such parties do not intend to create any such relationship by this EULA.

**18.5** If any provision (or any part thereof) is unenforceable under or prohibited by any present or future law, then such provision (or part thereof) will be amended, and is hereby amended, so as to be in compliance with such law, while preserving to the maximum extent possible the intent of the original provision. Any provision (or part thereof) that cannot be so amended will be severed from this EULA; and, all the remaining provisions of this EULA will remain unimpaired.
